Damage would include but not limited to, erosion from the property being developed, movement of heavy equipment, street openings, or other causes within the control of the applicant.

THE FOLOWING WORK MUST BE COMPLETED:

- 1. Bituminous Asphalt Apron must be installed.
- 2. Aprons must extend a minimum of 15 feet from the edge of the road.
- 3. All disturbed shoulders must be loomed & seeded a minimum of 15 feet from the edge of the road or as specified on permit.
